## 认证流程

- 1. **质量、环境、健康和安全管理体系认证**: 组织须先获得如 ISO 9001、14001、45001 认证且确保证书在有效期内,作为 R2 认证的基础。
- 2. 预评审及合同评审:对组织的申请信息、资质文件进行核实及审批,并确认所需的审核天数,安排专业的审核员。
- 3. 一阶段审核: 进行初步的文件审核,确保文件化的管理体系符合 R2 标准要求,并且组织应证明已和SERI签订符合性协议。
- 4. **二阶段审核**: 现场审核组织的回收实践符合 R2 标准。(注: 如一阶段或二阶段审核存在不符合项,需整改并验证通过后方可进入下一环节。)
- 5.**报告评定及发证**: 由R2体系经理进行报告评定及作出认证决定后,组织 将获得 R2 认证证书。
- ► 6.**年度审核**: 每年进行一次审核,确保组织持续符合 R2 标准要求。每三年进行一次再认证审核,以更新并持续证书有效周期。





## R2认证

## The Sustainable Electronics Reuse & Recycling



### What Are the Benefits

R2 Certification has been adopted by over 1,070 electronics reuse and recycling facilities across more than 40 countries. It serves as a gateway for businesses to become suppliers for leading companies, opening doors to brand supply chains.

- Gaining consumer trust: It enhances a business's competitive edge by securing trust from end consumers.
- Compliance with international environmental standards: Helps companies align with global environmental requirements.
- Showcasing corporate social responsibility (CSR) and sustainability commitments: Strengthens brand influence and market recognition.
- Following national policies on ESG (Environmental, Social, Governance)
  development: Assists companies in demonstrating their investment value
  and growth potential.

## **Certification Journey**

- Quality, Environmental, Health, and Safety Management System
   Certification: Organizations must first obtain certifications such as ISO 9001,
   ISO 14001, and ISO 45001, ensuring these certificates are valid, as a prerequisite for R2 certification.
- 2. Pre-assessment and Contract Review: Verify and approve the organization's application information and qualification documents, confirm the required audit days, and assign qualified auditors.
- 3.Stage 1 Audit: Conduct an initial document review to ensure that the documented management system meets R2 standard requirements. The organization must also demonstrate that it has signed a compliance agreement with SERI.
- 4. **Stage 2 Audit**: Perform a site audit to assess whether the organization's recycling practices comply with R2 standards. (Note: Any non-conformities identified in Stage 1 or Stage 2 must be rectified and verified before progressing to the next step.)
- 5. **Report Assessment and Certification Decision**: After evaluation by the R2 System Manager, the audit report will be assessed, and a certification decision will be made. The organization will then be issued the R2 Certification.
- 6. **Annual Audits**: Conduct annual audits to ensure the organization continues to meet R2 standard requirements. A recertification audit will be conducted every three years to renew and maintain the validity of the certification.
